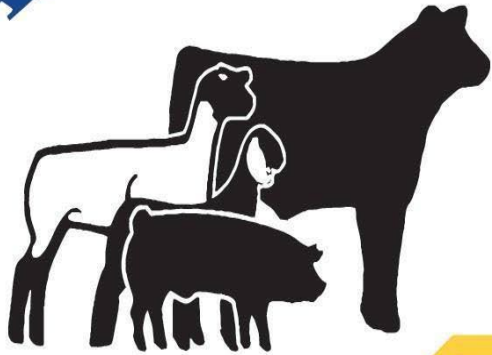

**Valencia County Fair 2025**  
**Rule Changes for 2025**

1. There will be a sifted show offered for animals not meeting weight requirements.
2. The Southdown Lambs weight changed from 70lbs. to 60lbs.
3. Each canopy and tent must have no more than 3 sides.
4. There will be only 1 fan per family or no more than 1 fan per 2 pens for Market Swine.
5. There will be a Pen Superintendent added for each exhibitor to check-in with, pay their fees and check-out with.
6. The new barn hours are from 6:00 am -12:00 am.
7. The Grand Champion Drive for all species will be placed out to 5<sup>th</sup> place overall.
8. A New Mexico Bred show was added.
9. Breeds have been added to the Breeding Heifer class.
10. Production Heifer has been changed to Ranch Heifer and breeds have been added.
11. This year the fair will have co-superintendents.
12. The Bucket Calf show will now be placed and awarded buckles.
13. The cost for the Poultry and Rabbit classes has increased from \$2.00 to \$3.00 for single, \$3.00 to \$5.00 for pairs and trios and Meat pens for both Poultry and Rabbit increased from \$5.00 to \$10.00.
14. Meat pen rabbits' weight has been changed to 5.5 lbs. to follow ARBA rules.
15. The complaint process has been reviewed, and a complaint form has been created.
16. The commission percentage has decreased from 8% to 6%.
17. Showmanship ages are now as follows:
  - Novice- 8-11 years old by January 1<sup>st</sup> of the current 4-H program year.
  - Junior- 12-15 years old by January 1<sup>st</sup> of the current 4-H program year.
  - Senior-16-20 years old by January 1<sup>st</sup> of the current 4-H program year.

## General Rules

### Valencia Fair Management Company, Inc.

1. The VFMC (Fair Board) reserves the final right to interpret these rules, settle and determine all matters, questions and differences regarding or connected with the Valencia County Fair.
2. In a case where no rule appears to cover a situation, the VFMC (Fair Board) will make a rule and define its application for such situations. General rules and regulations govern, but the special rules of each division take precedence over all other rules.
3. Any person who violates any VFMC rule will forfeit all privileges and premiums and be subject to such penalty as the governing body may order.
4. Livestock and/or camper trailers are to be parked along the North fence in Livestock parking lot ONLY; no trailers may be parked inside the gates. **THERE ARE NO DUMPING FACILITIES OR ELECTRICITY PROVIDED.**
5. All open indoor exhibits must be entered on Saturday, August 16<sup>th</sup> and Sunday, August 17<sup>th</sup> between 12:00 pm - 7:00 pm.
6. All open indoor exhibits will be released on Sunday August 24<sup>th</sup> between 9:00 am-12:00 pm.
7. All 4-H indoor entries must be entered on Saturday August 16<sup>th</sup> between 2:00 pm - 4:00 pm.
8. Indoor 4-H entries will be released on Sunday August 24<sup>th</sup> between 10:00 am - 12:00 pm.
9. All indoor and livestock exhibitors must be checked out with the Department Superintendent.
- 10. NO PETS ALLOWED!**
11. The VFMC(Fair Board) may employ security guards and will take every precaution for the safety of visitors and exhibits but assumes no liability for personal injury, loss or damage to any property or patron due to the theft, fire, tornado, weather conditions or other causes.
12. There will be a gate admission fee on the nights with dances (Friday and Saturday).

1. Competition and Exhibition will be open to current members of Valencia County 4-H Clubs and FFA chapters. Exhibits must represent current projects.
2. IAFE ( International Association of Fairs and Expos ) Show Ring Code of Ethics rules will be followed. See entry form complete documentation and signature page. Online entry will have an initial box to acknowledge that you as an exhibitor and/or parental/guardian have read this.
3. Livestock entry fees are as follows:..

**Late Entries will be accepted until July 27<sup>th</sup>, 2025**

4. Exhibitor's administrative Fee -\$20.00 per Exhibitor due with entries July 6<sup>th</sup>, 2025, through July 20<sup>th</sup>, 2025.
5. Late entries must be received by midnight on July 27<sup>th</sup>, 2025.
6. All species must be properly declared and tagged at VFMC (Valencia County Fair) tag day and remain in the continuous possession of the exhibitor during the feeding period and under the supervision of the county agent or vocational agricultural instructor.
7. Documents required for tagging:
  - A. Bill of sale in exhibitors name or family name.
  - B. Health Certificate for all out-of-state animals purchased.
  - C. Face Papers for swine, those purchased in state.
  - D. Lamb and Goat Scrapie's tags are required.
8. The Livestock Committee has the authority to combine or change classes when deemed necessary.

9. Species classification will be announced and posted on the schedule. If you are not there, you must make prior arrangements for someone to weigh your animal for you. You are responsible for having your animal washed and cleaned before classification.
10. Trailers will be parked in designated areas only. No trailer will be parked inside the gates. See General Rule #4.
11. There will be no electricity guaranteed by Valencia County Fair. Generators are encouraged but not allowed in the barns.
12. Weight limits at the scales shall be as follows:

Market Beef	900 lbs.- no top weight
Production Beef Steers	900 lbs. -1,400lbs.
Pee-wee Bucket Calf	500 lbs. max
Market Swine	200 lbs.- 300 lbs. max
Market Lambs	85 lbs. minimum
Southdown Lambs	60-lbs. minimum
Market Goats	50 lbs. -125 lbs.
Breeding Does	50 lbs.- 225 lbs.-max
Fryer & Meat Pen Rabbits	Not to exceed 5.5 lbs. per animal
Market Meat Pen Poultry	4-6 lbs. per bird (12-18 lbs. per pen)

13. Any animal weighing over or under the above stated weights will be allowed to show in a sifted class only and will be allowed to participate in showmanship.
14. All animals must remain in the livestock area once they are checked in and remain there until released by the superintendent of that species. The livestock area is defined by the check-in gates up to the West drainage ditch fence line, the area South of the pig barn and show ring to the South boundary fence and the area between the West drainage ditch fence line and the rabbit and poultry barn.
15. All Animals must be in the appropriate barn between the hours of 10:00 pm - 6:00 am provided there is enough room deemed by the Livestock Chair.
16. **Early Release:** - At the time of check-in an intent of **NOT TO SALE** must be signed by parent and exhibitor and it must be turned into Livestock office by 10:00 pm on Monday, August 19<sup>th</sup>. It will include tag number of animal(s) or description of small animals (poultry and rabbit) to be released 2 hours after the last show on Thursday or when an announcement has been made. You will check out with the Livestock Superintendent **ONLY** and no other animals may leave at that time.
17. Each exhibitor is responsible for the care of his/her own animals until the species Superintendent has issued a release. If animals are not properly cared for, labor and feed charges will be assessed to the owner/ exhibitor (minimum daily charge of \$25.00 for any species). Any premium or sale money won by such an exhibitor will be withheld and applied toward the fee assessed. The balance will then be released to the exhibitor as normal.
18. Exhibitors will be assigned a pen or stall space by the Superintendents.
19. All animals must be kept groomed, clean and in show condition.

20. Exhibitors will be responsible for cleaning up your clippings and properly disposing of them or a \$50.00 cleaning charge will be imposed.
21. Stalls and pens must also be kept clean, neat and clear for spectators.
22. Exhibitors must furnish their own water pails and feed pans/buckets.
23. Recommended dress code: Exhibitors should be appropriately dressed for show ring.
24. There will be a pen cleaning fee per stall or pen depending on the species.
25. Exhibitors may use **wood shavings or straw bedding** in beef and dairy stalls only. There is a refundable \$30.00 per stall deposit required for each head tie off rail used. Deposits will be made at the time of check-in and will be refunded at the conclusion of the fair. Refunds will be issued by the Pen Superintendent at check-out once the stalls are sufficiently cleaned at the discretion of the Pen Superintendent.
26. **Only pelletized bedding will be allowed** in Market Swine, Market Goat & Market Lamb pens. There is a refundable \$20.00 per pen deposit. Deposits will be made at the time of check-in and will be refunded at the conclusion of the fair. Refunds will be issued by the Pen Superintendent at check-out once the pens are sufficiently cleaned at the discretion of the Pen Superintendent.
27. Your pen cleaning deposit(s) must be paid by the end of the livestock check-in day, Monday August 18, 2025, by cash or check ONLY! You will not be allowed to show in your respective class until all your fees are paid.
28. The Pen Superintendent(s) will be responsible for collecting and returning the pen cleaning fees once the stall(s) or pen(s) have been cleaned satisfactorily to them.
29. Canopies, tents and shelters will not be allowed to be totally enclosed, a maximum of 3 sides will be allowed to be enclosed.
30. Exhibitors & Representatives will be permitted on the grounds from 6:00 am - 12:00 am.
31. Livestock will be accepted on the grounds as follows:

Dairy Cattle	Monday, August 18th 7:00 am - 11:00 am
Dairy Goats and Pygmy Goats	Thursday, August 21 <sup>st</sup> 7:00 am - 7:30 am
Rabbits, Poultry, Beef Cattle,	Monday, August 18 <sup>th</sup> 7:00 am -11:00 am
Market goats, Market Lambs and Market Swine	Monday, August 18 <sup>th</sup> 7:00 am- 11:00 am
32. All animals presented for the exhibition shall be free from contagious/infectious diseases and be subject to examination during the fair. Any diseased animal will be removed from the fairgrounds. Fair veterinarian recommendations will be followed.
33. Any animal deemed by the Livestock Committee as unsafe will not be allowed to show and must be removed from the fairground immediately.
34. The Superintendent reserves the right to refuse entry of stock for competition that is in his/her judgment not in suitable show condition.
35. If any animal must be tranquilized for safety or other reasons, this may be done, and such animals must be removed from the fairgrounds and are not eligible for show or sale.

36. Only veterinarian prescribed drugs will be allowed on grounds with Livestock Superintendents approval and appropriate paperwork from the veterinarian.
37. Any medication will be given under the supervision of the Livestock Superintendent and/or fair veterinarian along with proper paperwork.
38. All veterinarian expenses incurred shall be the sole responsibility of the exhibitor.
39. All animals entered in this Fair will be reviewed by the Livestock Committee. Inferior animals will be eliminated and must be removed from the fairgrounds at the discretion of the Department Superintendent.
40. Livestock exhibitors must provide proof of a (negative) Tuberculosis test as applicable per **New Mexico Livestock Board(NMLB)** rules.
41. Livestock exhibitors must provide proof of a (negative) Brucellosis (bangs) test as applicable per **New Mexico Livestock Board(NMLB)** rules.
42. **ALL ANIMALS MUST MEET NEW MEXICO LIVESTOCK BOARD (NMLB) HEALTH RULES**
43. The following are unethical practices and will be dealt with as described below:
  - A. Doctoring, doping or injecting show animals for body "fill-in".
  - B. Changing, defacing, or modifying the marking of show animals or the anatomical structure of an animal, which includes the removal or alteration of ear tags.
  - C. The external application of liniments or blistering agents which would cause an edematous condition.
  - D. Force filling practices for the purpose of weight gain and/or body fill.
  - E. No "Hot shots" or electrical stimulation devices.
44. **ANY EXHIBITOR OR PERSON RESPONSIBLE PARTY FOUND GUILTY OF ANY OF THE ABOVE LISTED UNETHICAL PRACTICES, OR ANY OTHER PRACTICES DEEMED UNETHICAL BY IAFE OR BY THE MANAGEMENT, WILL FORFEIT ALL PREMIUMS, AND ALL SALE MONEY OVER THE PACKER'S BID. IN ADDITION, THE OWNER/ EXHIBITOR OF THE ANIMAL WILL BE BARRED FROM FUTURE PARTICIPATION UNTIL SUCH TIME AS THE MANAGEMENT MAKES RE-INSTATEMENT.**
45. The Grand Champion Drive for all species will be placed out to 5<sup>th</sup> place overall.
46. Non-sale animals will be released on Sunday, August 24<sup>th</sup>, 2025, between 8:00 am - 10:00 am. Sale animals will be released only on Sunday August 24, 2025, at 12:00 pm. Please see the release times on the schedule of events. All animals must be checked out through the department (species) Superintendent. No exceptions.
47. All livestock in registered breeding classes must have certificates of registration in the name of the exhibitor. The certificate of registration must be checked by the Superintendent of the department. Breeder's identification will be accepted. Breeding stock may not be used for market shows. All grade animals will be identified.
48. **Judging for Champion of Breed**-only the 1<sup>st</sup> place animals will be considered. Judging for Reserve Champion of breed- only 2<sup>nd</sup> place animal in the class from which the champion was selected, will be eligible to move up for Reserve Champion consideration or at Judges Discretion.

49. **Judging for Grand Champion (Breed Specific Classes)**- Only Champion of Breed animals will be considered. Judging for Reserve Grand Champion- Only the Reserve Champion of Breed animal, in the class from which the Grand Champion was selected, will be eligible to move up for Reserve Grand Champion consideration or at Judges Discretion.
50. **Judging for Grand Champion (Breeding Classes)**-Only Division Champion animals will be considered. Judging for Reserve Grand Champion, only the Reserve Division Champion of the division, in the class from which the Grand Champion was selected, will be eligible to move up for Reserve Grand Champion consideration or at the Judge's discretion.
51. The market animals to be shown will be limited to 10 animals per exhibitor (no more than 3 beef or 6 sheep, swine or market goats FOR EXAMPLE: 3 beef and 3 sheep and 4 swine). There is no limit on breeding or dairy animals. Production steer entries are limited to no more than 2 production steers. Production steers do not count toward the limit of 10 animals per exhibitor.
52. If an exhibitor has cause to be unable to show his/her animals during the Valencia County Fair, the exhibitor must notify the Fair Board by the 2025 August regularly scheduled monthly meeting, held at the Valencia County Fair Grounds at 7:00 p.m. on the first Tuesday of the month. The Fair Board will decide if an alternative can be used. The alternate must meet all the requirements of the exhibitor. If an emergency arises after the August meeting, the exhibitor can notify the Livestock Chairman, and a special case ruling will be made at that time by the Livestock Committee.
53. In order for any individual transferring in from another county or state to qualify as an exhibitor of Valencia County Junior Livestock Show, he/she must provide proof of current membership in a 4-H or FFA program elsewhere. Minimum animal ownership requirements must also be verified by the previous 4-H or FFA instructor in writing. The exhibitor will not be allowed to show if he/she has already shown or plans to show the animal in another county.
54. Anyone desiring to make a complaint during the fair may do so in the following manner:
  - A. Fill out the complaint form in full detail and submit it to the Species Superintendent or Livestock Office with a money order, cashier's check or cash for \$100 per complainant signature. No personal checks.
  - B. A minimum of five (5) board members will meet and give a ruling on your complaint. If the ruling goes in your favor, you will get your money back. If the ruling goes against you, the VFMC will retain the funds. This applies to all departments.
  - C. All complaints must be made by the end of day, which the complaint pertains to.
  - D. Blank complaint forms are in the Livestock office and at the back of this book.
55. **Not applicable for 2025 fair**- Gate admission passes are available for junior livestock exhibitors via the livestock entry forms for Friday, August 23<sup>rd</sup> and Saturday, August 24<sup>th</sup>. Passes for livestock exhibitors are free. Passes for immediate family (parents/legal guardians and siblings) are available for \$2.00 and must be purchased at time of livestock entry. These passes will not be sold during the fair. Each pass will admit one for both Friday and Saturday from 6:00 am-6:00 pm. Children 3 and under are free. There are no admission fees for Monday, August 19<sup>th</sup>-Thursday August 22<sup>nd</sup> or Sunday, August 25<sup>th</sup>. **There will be no gate admission this year except for the dances of 2025**

**Drug Testing Policy**

1. **Drug Residue Testing:** Exhibitors and parents/guardians' consent and agree that any market entries may, at the discretion of the Valencia County Fair, be tested for unauthorized use of medication or drugs. They further certify that they will not administer their market entry with any substance not approved by the FDA and/or the USDA for this species. (For Example, they will not give a substance labeled as swine feed supplement to poultry.) Their entry is not, nor will it be, within any withdrawal time relative to the administration of any drug, chemical, or feed additive approved by the FDA and/or the USDA by the time the animal(s) is officially checked in to the County Fair. As a condition for participation in the show, every exhibitor must agree to submit their animal(s) for testing any time after check-in. The Fair Board reserves the right to perform any test, including but not limited to tissue, blood and/or urine laboratory analysis, on the Grand and Reserve Champions, along with a random group of animals from each division. The exhibitor and his/her parent/guardian must be present during the collection for testing and must witness the sample; thus, verifying the sample to be properly collected and prepared for analysis. The Valencia County Fair reserves the right to condemn and/or disqualify any animal, either alive or dead, found in violation of the use of any drug, chemical or feed additive as described above, and the exhibitor will forfeit all awards and sale proceeds and be subject to testing at future county fair shows. If an animal is disqualified for testing positive and/or the carcass condemned at slaughter, the disqualification will not impact class or overall placings for the species.
2. If a sample tests positive for illegal drug residue during the preliminary test, the parent/exhibitor has the right to request a second test to confirm the results. The second sample taken from the same animal will then be taken to a private firm for further testing. The parent/exhibitor will be responsible in advance for all costs associated with this second test. Knowledge of this pending information will only be made available to the Valencia County Fair Board for privacy purposes only.
3. **Emergency Treatment:** If an animal requires emergency treatment while on the fairgrounds, only a licensed veterinarian with the prior approval of the Valencia County Fair Livestock Committee will be allowed to administer a drug, chemical or feed additive. All treatment costs are the responsibility of the exhibitor. All treated animals are still subject to the Wholesome Meat Act. For a treated animal(s) to remain eligible for sale, the exhibitor must make arrangements with the buyer to hold an animal until it is clear of any withdrawal period. The Livestock Committee must be notified of and approve this arrangement, and it will be announced prior to the animal being sold in auction.
4. Exhibitors refusing to submit their animal/pen for drug testing will be disqualified and must remove their animal/pen from the fairgrounds immediately.
5. **Ultimate Care and Responsibility:** By making entry into Valencia County Fair, the exhibitor agrees and understands that ultimate care and responsibility for an animal/pen rest solely upon the exhibitor until such time that possession of the animal is turned over to the buyer.
6. Exhibitors are encouraged to stay with their animal/pen during the hours the livestock area is open. No one, other than security and Livestock Committee representatives, will be allowed in the livestock area when it is closed.
7. Any sample collections, for the purpose of drug testing of the animals will be done by a licensed Veterinarian.

**JUNIOR LIVESTOCK SALE**

**\*\*STARTS AT 6:00 PM - Saturday, August 23, 2025**

1. Market livestock will be sold in the order by the class placings.
2. Exhibitors are responsible for the care of all animals after the sale. Sold animals will be released for proper delivery to purchasers on Sunday, August 24, 2025.
3. Money derived from the sale of market animals will be mailed to the exhibitor by the VFMC Board Treasurer after the County Fair once all livestock sale money has been collected and/or at the discretion of the board.
4. The official sale weight for steers will be the actual weight taken at the fairgrounds for show. The minimum weight on market steers is 900 lbs. (with no sale animals weight charged about 1, 400lbs.). The official sale weight for market swine, market sheep and market goats will be the actual weight taken at the fairgrounds for show.
5. Terms of the sale are final unless prior arrangements are made with the salesclerk. Buyers will be expected to settle with the salesclerk immediately after the sale. Direct transactions with the seller are not permitted. Absolutely no pull outs.
6. Sheep, market goat and swine sale places will be combined to 66 total sale slots (unless the criteria are or are not met and the Sale Committee changes total number). For the purposes of the sale, Market Sheep and Market Goats' numbers will be combined. Only ribboned livestock will be eligible for sale. The total number of sale slots for each species will be determined by their percentage at the fair, with no less than 5 market beef to be sold. EXAMPLE: If 150 Market Lambs and 140 Market Swine are registered at the fair, the total number of Market Lambs and Market Swine would equal 290. 150 Market Lambs out of 290 animals  $150/290=52\%$ . 140 Market Swine out of 290 total number  $140/290=48\%$ . This would mean that 52% (34) of the 66 sale slots would be given to Market Lambs and 48% (32) of the 66 sale slots would be given to Market Swine. In no case shall either species receive less than 25 sale slot positions. The market livestock officials and sale committee reserve the right to decrease these numbers at any time in accordance with the total number of animals shown and buyers' support.
7. Sale is limited to 2 animals per exhibitor but not more than 1-Bovine (dairy, beef) or meat pen.

**EXAMPLE** : An exhibitor may sell any of the following examples:

1-Bovine & 1-Market Lamb	1-Bovine & 1-Market Swine	1-Market Lamb & 1-Market Swine
1-Bovine & 1-Market goat	1-Rabbit & 1-Market Lamb	

8. All livestock sold through the sale, including add-ons, shall be charged 6% to defray judging and sales expenses. The Fair Board will not be responsible for animals not listed in the auction.
9. Any exhibitor who wishes to withdraw from the sale must notify the designated official during the allotted time. Pulls will be after the last livestock show for one hour. Time to be determined by the Livestock Committee. Any junior exhibitors who have an animal entered in the sales are prohibited from seeking special privileges from buyers, such as asking permission to re-purchase the animal from the buyer or packer for the purpose of showing again or for other uses. Any exhibitor or their agent who harasses or seeks special privileges will be subject to disciplinary action as deemed necessary by fair management, including withholding any sale money. Any questions on the sale of the animals or payments should be directed to the VFMC (Fair board).

10. Market Swine, Market Goats and Market Sheep will be considered for sale on a percentage basis of each species however, each Champion of Breed shall be eligible to sell regardless of the percentage.

**EXAMPLE:** 100 market swine entered, 10 Hampshire  $10/100 \times 17 = 1.7$  market swine sell of the Hampshire which means Champion and Reserve Champion of Breed sell. Because each Champion of Breed will sell our percentages could be off. Not at any time will more than the maximum number of animals be allowed to sell. The sale committee shall determine if the decimal place will be rounded up or down because of the maximum number of animals allowed to sell. The number of each breed to be sold will be posted prior to the show.

11. If an animal eligible for sale is withdrawn from the sale, the next highest placing animal in the class in which the withdrawn animal was shown will be eligible.
12. No baskets for buyers are to be handed out during the sale.
13. Animals are to be show ready for the sale.
14. Resale of any animal(s) sold in Junior Livestock Auction will be reauctoned at the end of the sale.
16. If livestock is treated on grounds by a certified vet for any reason and the withdrawal period exceeds the Wholesome Meat Act specifications, the exhibitor must house the animal until the withdrawal period has passed. This will be announced during the sale.
17. **WHILE ANY SALE ANIMAL IS ON THE FAIRGROUNDS THE ONLY SALE TRANSACTION ALLOWED ON JUNIOR LIVESTOCK SALE DAY ARE THROUGH THE SALE RING.**

1. Pee-Wee shows will include Market Goats, Market Lambs, Market Swine, Bucket Calf, Rabbit and Poultry.

3. Pee-Wee exhibitors may tag and raise their own animal(s) or may show a borrowed animal owned and exhibited by an exhibitor. It is the Pee Wee participant's responsibility to make arrangements to borrow livestock.
4. **All animals must be tagged and must be compliant with New Mexico Livestock Board (NMLB) of health rules.**
5. Pee-Wee show is a participation show only. Animals will not be placed. Participation ribbons will be given to all participants.
6. Any Pee-Wee Participant under the age of 5 must be accompanied by an adult in the Showring.
7. There will be no entry fee.
8. Signing up for Pee-Wee show waives all liability to VFMC. Entries must be turned into the Pee Wee Coordinator prior to the show starting.

**Bucket Calf Rules 2025**

**The purpose of this program is to teach youth who are not old enough for a market project, the responsibility of raising and caring for a livestock project.**

1. Calves must be less than 500 lbs. by the date of the show.
2. Animals will be placed: 1<sup>st</sup> through 6<sup>th</sup> at the Judge's discretion and will receive prizes (to be determined by the Bucket Calf committee). No bucket calves are eligible for a sale slot.
3. All participants must be 5-8 years old, in kindergarten **under** the required age of a 4-H Novice and an active member of a Valencia County 4-H club.
4. Online Entry forms and fees must be received by Sunday, July 20<sup>th</sup>, 2025. Late entries must be received by Sunday, July 27<sup>th</sup>, 2025.
5. Exhibitors will be allowed to show only one calf. Each exhibitor must have their own calf. **Sharing calves is not allowed.**
6. All calves must be halter broke. If a calf becomes uncontrollable and the child cannot handle the animal, they will be provided with assistance by the adult accompanying them or the animal will be removed from the show ring for the safety of the other exhibitors. \*
7. Calves can be any sex or breed.
8. A signed release form must be signed by a parent or guardian and turned in at check in.
9. A show stick is recommended.
10. A separate pee-wee bucket calf show will follow showmanship for those under 5. This class will be a participation ribbon only.

**Bucket Calf Showmanship**

1. Showmanship will take place immediately following the bucket calf show.
2. Showmanship will be done at the judge's discretion. The calves being shown must be owned by the exhibitor.
3. Judging will be based on the participant's ability to show their calf, the knowledge of the animal and some consideration will be given to the appearance of both the exhibitor and their animal.
4. 1<sup>st</sup> place will be given the title of Grand Champion and 2<sup>nd</sup> place will be given the title of Reserve Grand Champion. Grand and Reserve will be presented with a buckle at the buckle ceremony.
5. Dress Code is recommended: Long sleeved, button-up shirt, tucked in, dark blue jeans and boots.
6. All participants will be given a list of questions that could potentially be asked of them by the judge.

- Buckles for Grand Champion and Reserve Champion
  - Ribbons for 1<sup>st</sup> through 6<sup>th</sup> place in respective class at the Judge's discretion
1. Market- beef must have all their temporary incisors. No beef will be permitted to show that has lost its temporary teeth at the time of sifting. All beef will be checked by the Livestock Committee and the official fair Veterinarian. Their decision will be final.
  2. 900 lbs. minimum weight, no top weight.
  3. Heifers are allowed to enter and show.
  4. Market beef will be divided into classes by weight not hip-height or breed. The market beef will be listed by consecutive weights. The livestock Beef Superintendent will divide the beef into two or more equal classes based on the consecutive weights.
  5. There will be a mandatory meeting of all beef exhibitors prior to the start of weigh-in. Classes will be divided by weight
  6. For each beef the space allotted is 4 ft. All fans and stands must fit inside the 4 ft space.
  7. For stalling, dividing panels can be between 8-10 feet long.
  8. Beef neck ropes are mandatory for the safety of the animal, exhibitor and public. All beef animals are mandated to wear a neck rope while in stalls.
  9. Judging for Champion of breed-only 1<sup>st</sup> place animals will be considered. Judging for Reserve Champion of breed-only 2<sup>nd</sup> place animals in the class from which the Champion was selected, will be eligible to move up for Reserve Champion consideration.
  10. Fitting Regulations: This is a full fit show.
  11. Any clippings will need to be properly disposed of or a \$50.00 clean up charge will be imposed.
  12. Exhibitors are responsible for keeping pens neat and aisles always clear. Cattle are to be maintained by the exhibitor throughout the show, making sure they are well kept, well groomed, and in show condition. Public aisles and walkways must be kept clear of tack, chairs, equipment and animals.

- Ribbons 1<sup>st</sup> through 6<sup>th</sup> place in respective class at the Judge's discretion
- Scholarship for Overall Grand Champion, \$1,000
- Scholarship for Reserve Grand Champion, \$500

1. This is a premium show. Animals in this class will not be eligible for the Junior Livestock Sale. Rule 7 of the Junior Livestock Sale Rules does not apply to this class.
2. All exhibitors who wish to show in the production steer show must declare for the show on tag day. All participants and parents will sign a consent form acknowledging this is a terminal show. The top 6 head placed during the live show will be slaughtered the day following the show at the designated packer.
3. Production class steers must be no older than 30 months of age. Any steer determined by the carcass judge to be over this age will not be eligible for Grand and Reserve Champions. The decision of the carcass judge will be final. Minimum live weight for production steers will be 900 pounds with the max pay weight not to exceed 1,400 pounds.
4. The space allotted for each steer is 4ft. All fans and stands must fit inside the 4ft. space.
5. The Production Steer Class is a "Slick Show". NO artificial coloring, glues, or adhesives will be allowed, no exceptions, while on the Valencia County Fairgrounds. All production show steers must be sheared to a hair length of no more than 1/4 inch including ears and tail head. Hair may be left 10 inches from the bottom of the tail.
6. Any clippings will need to be properly disposed of or a \$50.00 clean up charge will be imposed.
7. All participants will be judged in the ring and on the rail. Grand and Reserve Champions will be determined by a combination of live evaluation and carcass performance, with an emphasis on carcass quality grade and yield grade. The carcass judge will be evaluating quality grade and yield grade for each contestant. Exhibitors will be required to go through the cooler with the judge once he/she is finished with an explanation of how they have been evaluated per industry standards. Grand and Reserve Champions will be awarded and announced at the awards ceremony.
8. **Live Evaluation Criteria:** Steers must be halter broke and shown to be placed. Exhibitors must know the average daily gain of their project from tag day to check-in at the fair.
9. All animals will be sold as live animals, per lb. live weight. Sale price to be based on live weight and market price as of July 1st plus \$0.20/lb. Max pay weight is 1,400 lbs. Live sale weight will be determined by the official check-in weight at the Valencia County Fair. Valencia County Fair will create a list of buyers and sell the animals on a first-come, first-served basis. If the exhibitor wishes to keep the beef, he/she shows, this will be allowed, however the animal will still be required to go to the designated packer for carcass evaluation purposes.

10. **Carcass Criteria** : To be eligible for Grand Champion and Reserve Champion are as follows:

- A. Minimum hot carcass weight: 560 lbs.
- B. Maximum hot carcass weight: 950 lbs.
- C. Minimum 1.6 square inch of Rib Eye Area per 100 lbs. of hot carcass weight
- D. Yield Grade: grade not to exceed 4.0.
- E. Minimum Final Carcass Grade: Select 70

11. Final Determination of Grand Champion will be determined by adding the total points received by the exhibitor. Points will be awarded as follows:

- A. Live Evaluation: 6 points for 1<sup>st</sup> place, 5 Points for 2<sup>nd</sup> place, 4 points for 3<sup>rd</sup> place ....
- B. Quality Grade: 6 points for highest quality grade, 5 points for 2<sup>nd</sup> place , 4 points for 3<sup>rd</sup> place ....
- C. Yield Grade: 6 points for best yield grade, 5 points for 2<sup>nd</sup> place, 4 points for 3<sup>rd</sup> place ....
- D. Any tie breaker needed will go to the animal with the highest quality grade.

  5. All wool sheared on fairgrounds will be properly disposed of by the exhibitor or a \$50 per Market Lamb pickup fee will be imposed.
  6. 85 lbs. minimum weight, Southdown lambs 60 lbs. minimum weight, no top weight.
  7. All Market Lambs will need to be stripped of blankets/coverings and leg wraps before entering the ring for classification and weigh-in.
  8. Fitting Regulations: This is a full fit show.
  9. Exhibitors are responsible for keeping pens neat and aisles always clear. All Market Lambs are to be maintained by the exhibitor throughout the Show, making sure they are well kept, well groomed, and in show condition. Public aisles and walkways must be kept clear of tack, chairs, equipment and animals.

1. All out of state Market Swine must have health papers to prove they have negative test results for Brucellosis and Pseudorabies or are from a certified Brucellosis free and Pseudo Rabies free herd or state. **BE SURE TO CHECK NEW MEXICO LIVESTOCK BOARD(NMLB) HEALTH RULES.**
  2. All Market Swine must have ear notches.
  3. All Market Swine classes will be set up by the Livestock Committee. The classes will be set according to the following breeds: Yorkshire, Duroc, Hampshire, Cross and Other Pure Breeds. Additional breed classes may be added at the discretion of the Livestock Committee.
  4. The bill of sale or other proof of ownership with the pig's ear notches will be used as verification of ownership upon entry to the 2025 Valencia County Fair. All swine will be inspected upon entry to the fair. If the animal's ear notches do not match the bill of sale or other proof of ownership submitted, the animal will be disqualified. If there has been any injury/damage to either of the pigs' ears that causes them to differ from the animals' bill of sale or proof of ownership, the exhibitor will need to contact the Valencia County Extension Agent to schedule an inspection of the injury/damage by a member of the Livestock Committee as soon as possible after the damage has occurred. The Livestock Committee member will inspect the injury/damage and note it on the bill of sale or proof of ownership.
  5. The date and time for classification for Market Swine will be announced and posted. If you are not there, you must make prior arrangements for someone to weigh your swine for you. You are responsible for having your swine washed and cleaned before classification.
  6. A minimum of 4 Market Swine are necessary to constitute a breed class.
  7. 200 lbs. minimum weight, 300 lbs. top weight.
  8. Fitting Regulations: This is a full fit show.
  9. Fans will be permitted but only 1 fan per family or no more than 1 fan per 2 pens.
  10. Exhibitors are responsible for keeping pens neat and aisles always clear. All Market Swine are to be maintained by the exhibitor throughout the show, making sure they are well kept, well groomed, and in show condition. Public aisles and walkways must be kept clear of tack, chairs, equipment and animals.
  11. **Market Swine with sickness or abnormalities:** The Livestock Committee reserves the right to reject swine showing signs of sickness, lice, ringworm, (or other skin conditions including those commonly known as "fungus") abscesses, ulcerations, abnormality or uncontrollable temperament. 4. Wet Does over 2 years

1. **ALL** New Mexico Livestock Board rules apply regarding Certificates of Veterinary inspection, Tuberculosis, and Brucellosis. **BE SURE TO CHECK NEW MEXICO LIVESTOCK BOARD (NMLB) HEALTH RULES.**
2. Animals entered in the Youth Dairy Goat Show are not required to be registered with the American Dairy Goat Association.
3. Ear tags or tattoos will be checked and must correspond with tattoos recorded on the day of tagging.
4. It is recommended that exhibitors wear white while exhibiting animals in the ring.
5. All animals must have horns tipped to no larger than a dime.

  3. All Market Goats will be groomed for show with not more than 3/8 inch of hair over the hock.
  4. All Market Goats must be tagged with an official Scrapie ID tag, 4-H tags and tattooed prior to entry of fairgrounds.
  5. All Market Goats must have collars or halters to be shown.
  6. Fitting Regulations: This is a full fit show.
  7. Classes will be divided by weights:
    - Minimum weight- 50 lbs.

  4. Only the Grand Champion and Reserve Grand Champion Rabbit Meat Pen will be considered for the sale.
  5. Meat pens must not be over 10 weeks of age and not weigh over 5.5 lbs. The date of birth must be written on the entry form.
  6. A maximum of 3 pens per exhibitor is allowed.

**Junior Livestock Showmanship**

2. Age Specifications:

- Novice- 8-11 years old by January 1<sup>st</sup> of the current 4-H program year.
- Junior- 12-15 years old by January 1<sup>st</sup> of the current 4-H program year.
- Senior-16-20 years old by January 1<sup>st</sup> of the current 4-H program year.

3. All age groups will compete separately. Exhibitors who wish to show in one higher age group may do so.

4. Showmanship will be done at the judge's discretion. Animals being shown must be owned by the exhibitor.

5. Judging will be based primarily on the participant's ability to show, and some consideration will be given to the appearance of both exhibitors and the animal.

6. Exhibitors can only compete in Showmanship in the species they entered.

7. Criteria for Judging are as follows:

- Care and fitting of their animal
- Showmanship ability of exhibitor
- Training
- Conduct in the show ring
- Exhibitor dress

**Sifted Livestock Class**

1. Any animal that is sifted because of not meeting their weight requirements will be allowed to go home immediately following the official declaration of disqualification. If the exhibitor chooses to remove their sifted animal(s), and not show, they must be removed within 2 hours of the end of the sifting process. Any sifted animals not removed by the exhibitor during the allotted time will be charged a storage fee of \$20.00 a day per animal, unless the Livestock Species Superintendent and/or Livestock Chair approve the animal(s) to remain on the grounds. Exhibitors must check with the Department Superintendent for proper release procedures.
2. **Eligibility for Placing:** Sifted animals (those that did not meet weight requirements) may still be eligible for placement, 1<sup>st</sup> Through 6<sup>th</sup> place within a sifted class. Ribbons will be awarded.
3. **No Sale Slot:** Animals that do not make weight, do not qualify for the auction or premium sale.
4. **Sifting Process:** Livestock is weighed at the designated time and those outside of the designated weight range are classified as sifted animals.
5. **Disposition rules:** Exhibitors may have to follow specific procedures for handling sifted animals, including removal deadlines or times of show.

## Senior Round Robin Grand Champion Showmanship

- Only Senior 4-H and FFA Grand Champion Showman are eligible to compete in the Senior Round Robin Grand Champion Showmanship class.
- If the Grand Champion Showman is unable to participate, they must notify the Superintendent by 5:00 pm the day prior (or sooner if known) to the Round Robin Contest. In the event an exhibitor is the Champion Showman in two or more species divisions, the exhibitor will choose which species to show in the contest. The Reserve will then be eligible to participate.
- For safety reasons the animals best suited for Round Robin will be selected by the Superintendent of that species regardless of ownership. Four (4) market Swine will be selected, and the showmen may select one to show. The animals to be selected must have been shown in the respective fair showmanship classes, sifted animals are not allowed. Champion Senior showmen in the species showmanship contests will compete further by showing each other's entries, such as the 1<sup>st</sup> place winner in the beef will show the Market Swine entry, etc. They will be automatically awarded maximum points for showmanship in their species.

### **The following rules will apply:**

1. Coaching by an outsider(s) will result in disqualification.
2. Contestants will enter the ring dressed neatly and appropriately for the species in which they qualified to enter the Round Robin. NO CHANGE of apparel once the contest begins.
3. Each Champion showman of his species will give a courtesy demonstration at the beginning of the contest. Judges may narrate and give pointers.
4. Each Champion will show the animals selected for the Round Robin and be judged for points.
5. Qualified judges will judge each species.
6. Contestants will be required to walk the different species around the ring and demonstrate control and set the animals up except for Market Swine. Show sticks, bats, brushes etc. will be furnished with each animal as required to properly show each different species. Judges will use official score sheets to score their evaluation of each exhibitor. Judges will evaluate exhibitors using the following criteria: Control of animals, confidence, knowledge and appearance. Judges will ask questions of the participants.
7. Replacement of unruly animals – except for the swine, a replacement animal will be available in the event of an unruly animal.
8. Prior to the contest three species will be designated as the tie breaker.
9. Scores will be tabulated by an official scorer.
10. One official handler will assist with the rotations.
11. The ring steward will announce movements; introduce contestants, judges, etc.

12. Scoring will be by species with a maximum of 20 points for each of the following:

(A) Ability to properly show animals (20 points maximum) \_\_\_\_\_ Does the contestant demonstrate the proper ability to show the animal?

(B) Knowledge and control of the animal (20 points maximum) \_\_\_\_\_ Does the contestant demonstrate general knowledge and the proper reasonable and customary activities in the control and performance of the animal?

(C) Presentation of animal by showman. (20 points maximum) \_\_\_\_\_ Does the showman demonstrate the proper aspects and techniques of presenting the animal for judging?

### AGREEMENT OF RESPONSIBILITY AND LIABILITY

It is clearly understood that Valencia Fair Management Company, Inc. and its officials, officers, directors, and agents shall not be responsible for any damage, loss or injury to any person or property which is caused directly or indirectly for any reason. The exhibitor, owner, their agents and/or representatives agree to indemnify and hold Valencia Fair Management Company, Inc., and its officials, officers, directors, and agents harmless for any damage, injury or loss suffered during or in connection with the Valencia County Fair.

By applying for entry, Exhibitors, Owners, their Agents and/or representatives agree to comply with all the rules and regulations governing the Valencia County Fair as published in the Valencia County Fair book. Valencia Fair Management Company, Inc. has approved adoption of the National code of Show Ring Ethics (see below). Application of entry in the county Fair acknowledges the exhibitor, owners, their agents and/or representatives have read and the Valencia County Fair General Rules and Regulations, specific and/or special departments rules and regulations, and the National Code of Show Ring Ethics and agrees to observe and abide by these rules.

### IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS)

Exhibitors of animals at livestock shows shall always conduct themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured competition classes. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE National Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

1. All exhibitors must present, at the request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of drugs. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or person responsible for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event, which culminates with the animal entering the food chain, shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event.

If the laboratory report on the chemical analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or

other substance tested (by the approved laboratory to which it is sent) is the one taken from the animal in question. Its integrity is preserved and all procedures of said collection and preservation transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or responsible person to prove otherwise at any hearing regarding the matter conducted by the fair or livestock show. **SIGNATURES REQUIRED ON THE SECOND PAGE OF THIS FORM!** At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications shall be administered by a licensed veterinarian.

5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
7. Direct criticism or interference with the judge, fair, or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation, and respect and no person shall direct abusive or threatening conduct toward them.
8. No owner, exhibitor, fitter, trainer, or responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individuals to disciplinary action.
9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or responsible person to have any disciplinary action taken by the fair or livestock show against such individuals published in any publication of the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.
11. The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

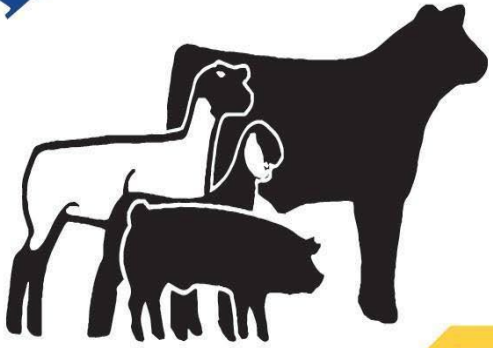
